MRS. EDITH PETTITT

Mrs. Edith Pettitt, a resident of Stow since 1916, has been a widow since 1924. Her late husband, George W. Pettitt, was in former years one of the Pettitt brothers who conducted a hardware store in Akion that still bears the name. Mrs. Pettitt was born in 1868, seared no family and has only one sister, Mrs. Taylor, who until recently lived with her husband at the Pettitt home in Stow.

This Pettitt and Taylor home in Stow was one of the old school church homes. Mr. Taylor is a very dear old man, always agreeable, always full of fun, and I think both he and his wife have passed the milestone of four score years. All of these three are devout Christians, Mrs. Pettitt a member (I think a charter member) of the community church in Stow.

Mrs. Pettitt, after the loss of her companion, paid a visit to the Taylor home then in LaGrange County. Indiana. The Taylors were farmers. Mrs. Pettitt prevailed upon her sister and Mr. Taylor to sell the farm and join her in the home in Stow. Plenty of room in the large house in Stow, they would be company for each other, and if the elder sister, Mrs. Taylor should become incapacitated, then her vounger sister, Mrs. Pettitt, would be her support and her comfort. So they lived very happily for a rumber of years.

But how strange is fate, how well our plans are laid and then

the unlooked for enters in. In the summer of 1941, Mrs. Pettitt suffered a stroke. This came like a flash from a clear sky. A year later or thereabouts, just when she was recuperating sufficiently to go about by the support of a cane, she fell and broke her hip. The good woman was then confined in a Cleveland Hospital for some time—then lo and behold—when joy came knocking at the door and the hour had struck for a homecoming, a farewell to the hospital and a reunion again with her good sister in Stow, the very ambulance that brought the Pettitt sister home, carried the Taylor sister to the Cleveland Hospital. She, too, had fallen and broken her hip.

In due time, however, the Taylor sister was discharged from the hospital and arrived home. So one sister was confined upstairs and one downstairs, but they could call to each other: they cheered and comforted each other.

Then that day, too, came to a close and another chapter of life began. The Taylors have a son, a resident of Niagara Falls, New York, Being anxious about his parents, he came and took them home with him, and Mrs. Pettitt finds a refuge in a rest home on Fir Hill, Adren.

So the evening shadows as ther: it is not as they had hoped or planned, perhaps it is the irony of fate, perhaps unavoidable circumstances, or perhaps it's just the trail but nevertheless the trail that leads Home.

MEDICAL CONFERENCE

A medical conference for preschool aged children is being conducted on the First Tuesday of every month from 8:30 to 10:00 a.m. at the Cuy. Falls Water and Light Building. The Conference is under the auspices of the Summit County Health Department. The next conference will be held on August 6, 1946.

A physician well-trained in giving advice on the care of children will be in attendance at the conference. He will be assisted by the public health nurses from the Health Department.

Only well children may attend

this conference.

The conference is for the purose of advising parents on how to keep the child well. A physical examination will be given. Also immunization for Diptheria and vaccination for Smallpox. Any child between 1 and 6 years of age who has no symptoms of a cold or other illness will be welcome at this conference.

Parents who are unable to secure medical advice from their personal physician to keep the child well may bring the child to this medical conference.

This conference is to serve residents of Cuvahega Falls and adjoining townships. It is one of four
